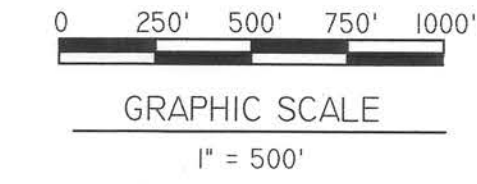

T.2S., R.3E. OF THE 3RD P.M., JEFFERSON COUNTY, ILLINOIS

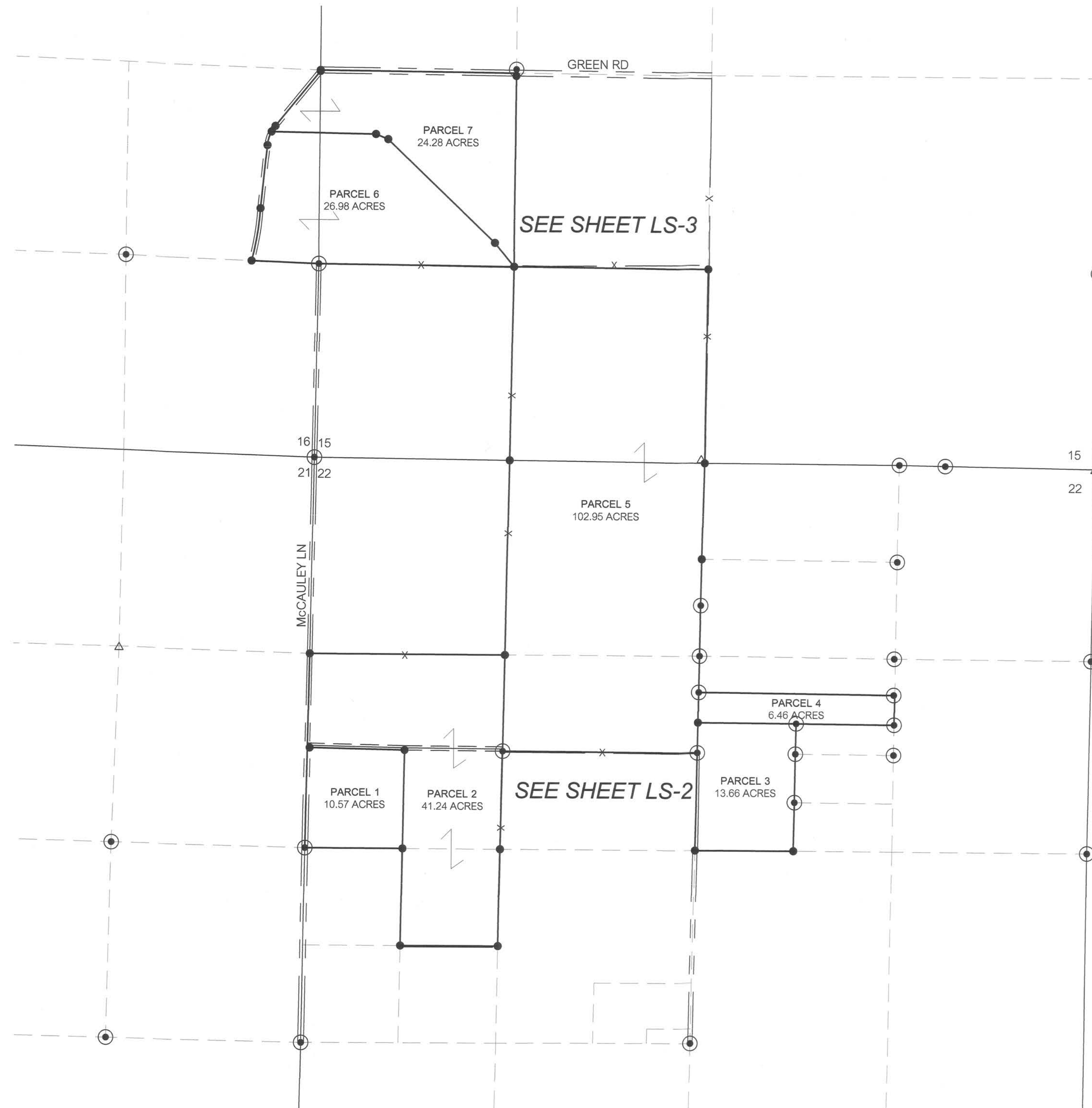

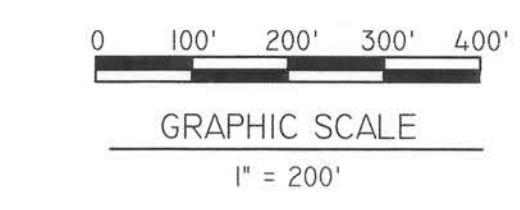

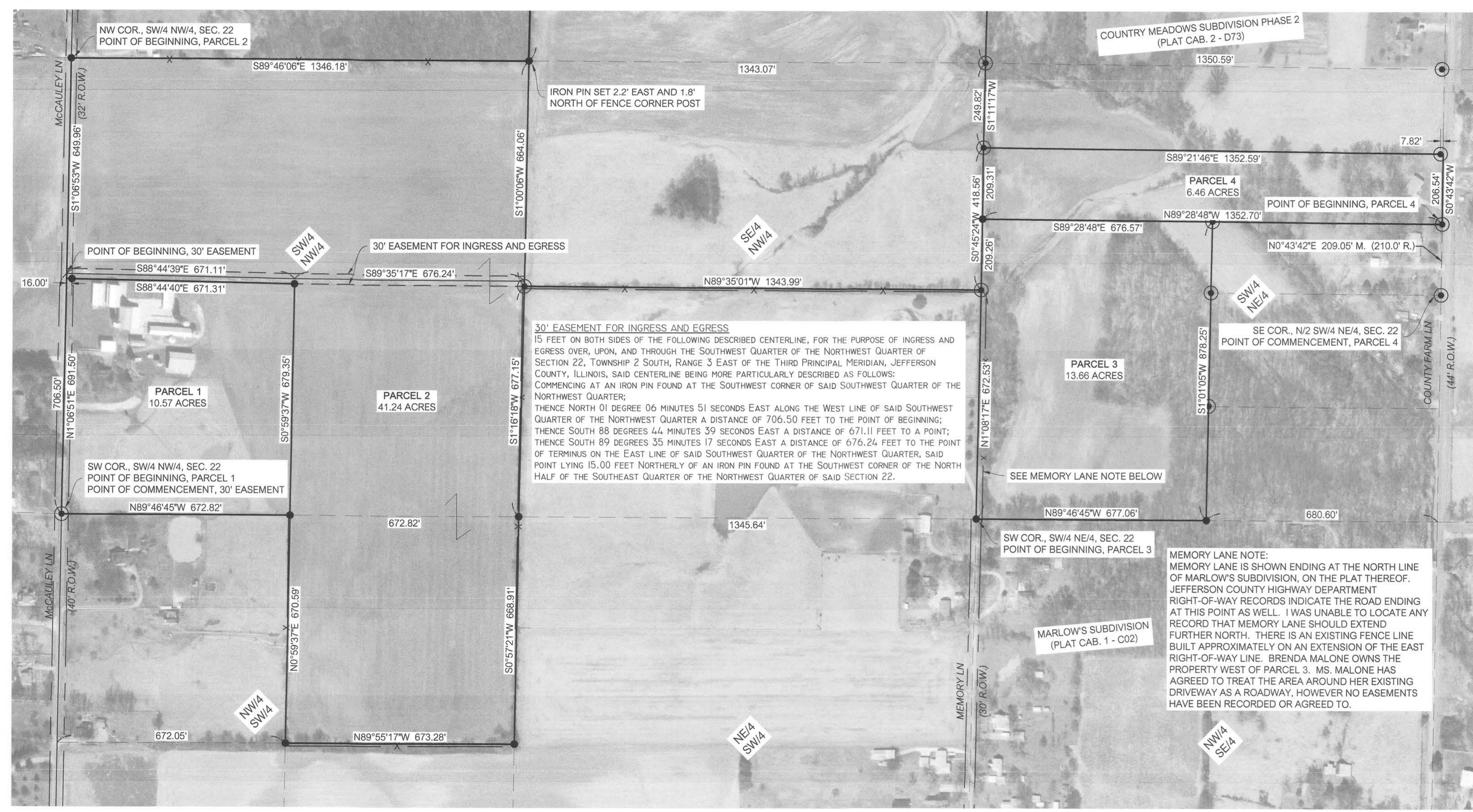

THENCE NORTH 01 DEGREE 06 MINUTES 51 SECONDS EAST ALONG THE WEST LINE OF SAID SOUTHWEST QUARTER OF THE NORTHWEST QUARTER A DISTANCE OF 691.50 FEET TO A POINT;
THENCE SOUTH 88 DEGREES 44 MINUTES 40 SECONDS EAST A DISTANCE OF 671.31 FEET TO AN IRON PIN SET, PASSING OVER AN IRON PIN SET 16.00 FEET FROM THE ORIGIN;

MEMORY LANE NOTE:
MEMORY LANE IS SHOWN ENDING AT THE NORTH LINE OF MARLOW'S SUBDIVISION, ON THE PLAT THEREOF. JEFFERSON COUNTY HIGHWAY DEPARTMENT RIGHT-OF-WAY RECORDS INDICATE THE ROAD ENDING AT THIS POINT AS WELL. I WAS UNABLE TO LOCATE ANY RECORD THAT MEMORY LANE SHOULD EXTEND FURTHER NORTH. THERE IS AN EXISTING FENCE LINE BUILT APPROXIMATELY ON AN EXTENSION OF THE EAST RIGHT-OF-WAY LINE. BRENDA MALONE OWNS THE PROPERTY WEST OF PARCEL 3. MS. MALONE HAS AGREED TO TREAT THE AREA AROUND HER EXISTING DRIVEWAY AS A ROADWAY, HOWEVER NO EASEMENTS HAVE BEEN RECORDED OR AGREED TO.

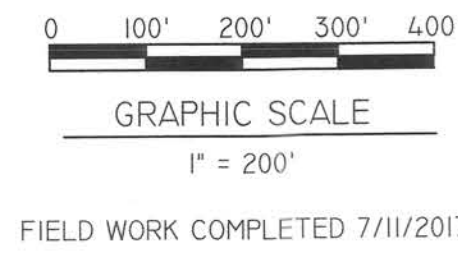

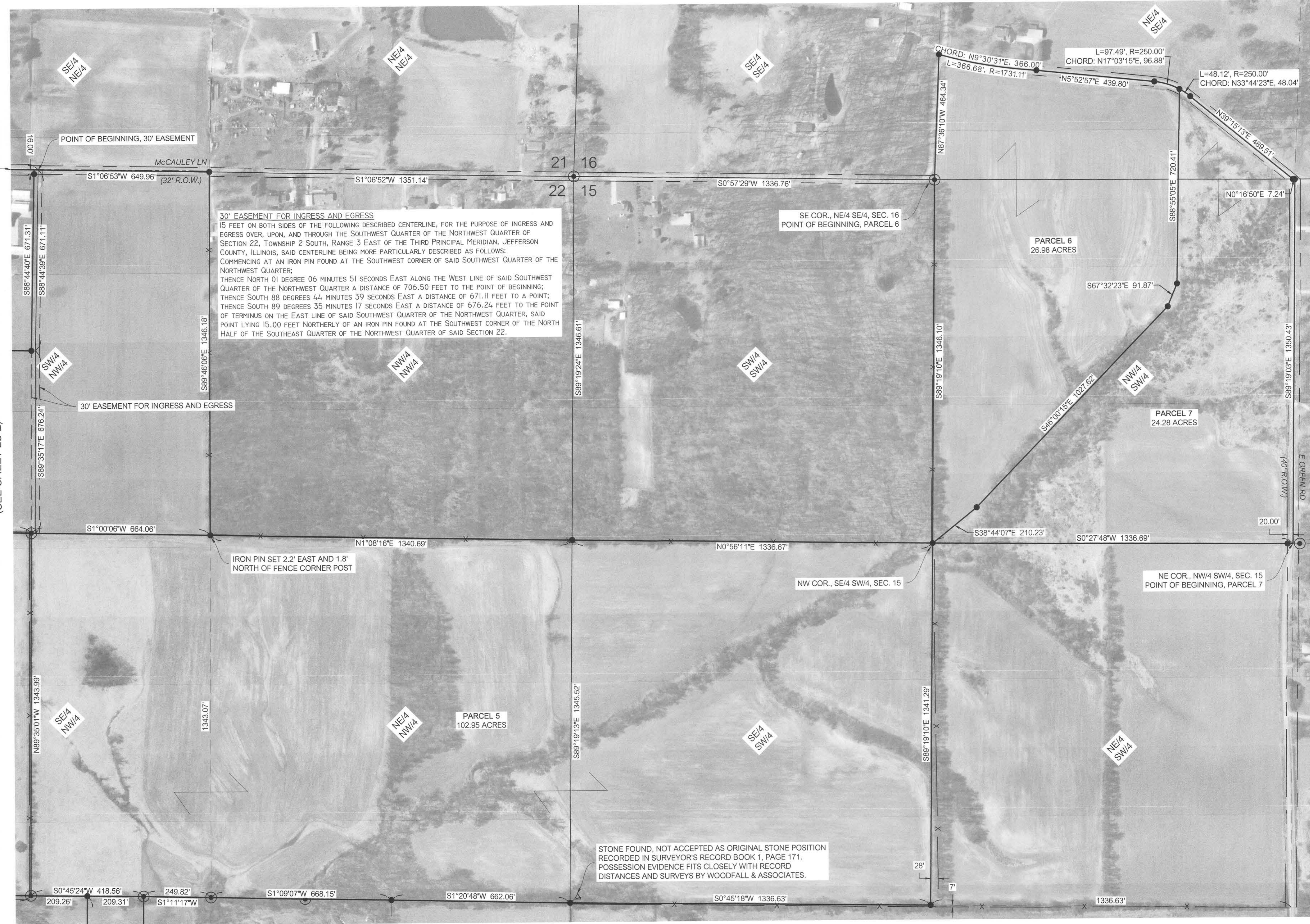
